LFI as the buyer will offer an outright purchase value based on the current market value, demand, and overall condition of the firearm being evaluated, this amount can change at any time. All firearms require a case, or the original box to complete the purchase. Holsters and/or gun socks do not satisfy this requirement. If one cannot be provided, a \$20 case charge will be deducted from the purchase value offered. Due to C.R.S 18-12-302 LFI will not accept any magazines over the capacity limit.

Purchase price will be issued by check only. **No cash, credit card, or merchandise card payment will be given.** If a merchandise card is desired, please refer to LFI's trade agreement.
