

# Background Check Agreement

## THE FOLLOWING STATUTES ARE REQUIREMENTS SET FORTH BY COLORADO STATE FOR ALL FIREARM PURCHASES:

- \_\_\_\_\_ Due to **C.R.S. 18-12-115**, I agree and acknowledge that LFI Shooting Sports (LFI) is required to hold all firearms for a minimum of 72 hours, and I will not be able to pick up my firearm(s) until after a minimum of 72 hours has passed.
- \_\_\_\_\_ Due to **C.R.S. 18-12-301 and C.R.S. 18-12-302**, I agree and acknowledge magazines with a total capacity of 15 rounds or less will be the only magazines provided for rimfire or centerfire firearms. For shotguns, tubular magazines that hold 28 inches or less or detachable magazines that hold 8 rounds or less will be the only magazines provided. ***I understand there will be no financial compensation or replacement if magazines are removed due to capacity restrictions.***
- \_\_\_\_\_ Due to **C.R.S. 18-12-405**, I agree and acknowledge that a lock will be given to me with each firearm.
- \_\_\_\_\_ Due to **18 U.S.C. 922(x)**, a Youth Handgun Safety Act Notice will be provided for all handgun purchases.

## THE FOLLOWING ARE LFI SHOOTING SPORTS' BACKGROUND CHECK TERMS AND CONDITIONS:

- \_\_\_\_\_ I understand all firearm sales, transfer fees, service fees, and background check (ATF Form 4473) fees must be paid upfront. I understand all fees are non-refundable regardless of approval or denial response received from the Colorado Bureau of Investigation, Insta Check Unit (CBI).
- \_\_\_\_\_ **LFI will not contact you if an approved response is received from CBI.** I understand after the 72-hour waiting period from the date and time posted on my receipt, I can pick up my firearm(s). I must present the same valid identification used for my background check along with my purchase receipt, in order to pick up my firearm(s).
- \_\_\_\_\_ **LFI will contact you by phone only if a denial or adverse response is received from CBI to discuss appeal or refund options.** LFI does not send text messages and is not responsible for unsuccessful contact attempts or undelivered voicemails.
- *Appeals are not submitted automatically. LFI will assist with the appeal process only at your direction.*
  - *All applicable refunds will be issued in accordance with LFI's return policy.*
- \_\_\_\_\_ I understand that background checks are valid for 30 calendar days regardless of approval or denial response, and cannot be used for any future firearm purchases. If my background check exceeds 30 calendar days, I will be required to complete and pay for a new background check. If the second background check exceeds 30 days, LFI will no longer assist in the background process, resulting in any applicable refunds being issued in accordance with LFI's return policy.
- \_\_\_\_\_ **LFI reserves the right to stop, deny, or cancel any firearm sale, or discontinue staff assistance, at any time, for any reason without explanation or notice.** In the event a background is canceled after submission to CBI, all applicable refunds will be issued in accordance with LFI's return policy.
